The Daviess County Commission will accept bids to furnish road rock for Daviess County, and Townships within Daviess County, up until **March 18, 2026**, at 10:00 a.m. in the following sizes:

All bidders shall make two bids:

1. Price per ton **FOB at quarry** available county-wide to the county, townships, and special road districts on 1.25" CART rock, 2" road rock, rip rap, and chips
2. Price per ton **delivered** to each township and special road district on 1.25" CART rock

Sealed bids may be mailed or delivered to Rachel Taylor, County Clerk, 102 N. Main St, Gallatin, MO 64640, until 10:00 a.m. on March 18, 2026, at which time the bids will be opened.

The Daviess County Commission requests that all bids be for the period of April 1, 2026, to March 31, 2027, and to be a firm bid. Please use the attached bid form. The Daviess County Commission reserves the right to accept or reject any/or all bids.

Invoices, accompanied by tickets, must be submitted at least monthly. All tickets must have a C.A.R.T. road number or Township name and be signed by a township official or employee.

The Contractor will receive a Notice to Proceed from the County Commission when the Township or Road District has been approved to receive rock under this bid. The total dollars listed on the Proceed Order must not be exceeded without prior written approval from the Commission.

CONTRACTOR IS TO BEGIN DELIVERY OF ROCK WITHIN TWO (2) WEEKS OF THE PROCEED ORDER.

The Contractor will permit County employees to access the quarry and scales to check weights and for other inspection purposes. The Daviess County Commission requests that local truckers be employed whenever possible. The most recent edition of the Missouri State Highway Standard Specifications will apply to all materials and requirements not listed in these specifications.
