

Minutes of the Daviess County Commission  
September 11, 2024

The Honorable Daviess County Commission met on this 11th day of September 2024 at 8:00 a.m. Jim Ruse, Presiding Commissioner called the meeting to order. David Cox, 1st District, and Wayne Uthe, 2nd District are present.

The Commission approved last week's minutes, brush letters, invoices for payment, and the tax sale abates.

James Lewis, Road and Bridge Supervisor updated the Commission on the projects they have worked on since last Wednesday. The crew replaced boards on a bridge on Hope Avenue. They also helped the City of Gallatin repair a streetlight on the West side of the Courthouse.

**OLD BUSINESS:**

No updates on the plaster project at this time.

The Commission plans to meet with one of the sidewalk bidders to confirm they have the bid information correctly.

The Commission is still reviewing an ordinance for Courthouse Security and Procedures.

**BRIDGES:**

The Commission reviewed BRO 002 Progressive Invoice #1 for payment. David Cox made a motion to approve the invoice. Wayne Uthe seconded the motion. 3 – Aye, 0 – No. Motion passed.

Gary McFee, Howe Co, presented the Commission with BRO 40 final design documents. David Cox made a motion to approve the final designs. Wayne Uthe seconded the motion. 3 – Aye, 0 – No. Motion passed.

**NEW BUSINESS:**

Rachel Taylor, County Clerk, presented her certificate of training for 20 hours. This should complete her training requirements for 2024.

The Commission discussed the Great Northwest Day planning meeting on September 19th. The Commission will be unable to attend because they will be at the Commission regional meeting in Chillicothe.

The Commission received an invoice for the construction on Quick Ave in Jackson Township. David Cox made a motion to use the funds in the Jackson Fund to pay for the invoice. Wayne Uthe seconded the motion. 3 – Aye, 0 – No. Motion passed.

The Commission reviewed a contract with the City of Gallatin and Annie Gibson, Prosecuting Attorney. The contract allowed Annie Gibson to prosecute any ordinances the City of Gallatin chose to enforce. Wayne Uthe made a motion to accept and sign the contract. David Cox seconded the motion. 3 – Aye, 0 – No. Motion passed.

In the afternoon the Commissioners inspected roads, culverts, bridges, and brush in Liberty and Jefferson Townships.

The meeting was adjourned at 2:30 p.m.
